- Class A: Retail sale on the premises specified, of alcoholic liquor for consumption on said premises as well as other retail sales of such liquor, on all days except as otherwise specified by law -- Annual Fee \$1,000.00
- Class B: Retail sale by not-for-profit clubs, nationally affiliated, on club premises, of alcoholic liquor for consumption on said premises by members and their guests, on all days except as otherwise provided by law -- Annual Fee \$500.00
- Class C: Retail sale of draft beer and wines with alcoholic content no greater than 20% by establishments which serve prepared and ready to eat food, such beer and wines to be served only with orders of such food and to be consumed only on said premises. There shall be no bar or bar stools in such licensed premises -- Annual Fee \$600.00
- Class D: Retail sale of packaged liquor of all kinds -- Annual Fee \$600.00
- Class E: Retail sale of packaged liquor of all kinds in an establishment physically located separate and apart from any other type of retail business -- Annual Fee \$800.00
- Class F: Retail sale of alcoholic beverages by bowling alleys. The sale of alcoholic beverages shall be incidental to the primary function of the subject premises as a bowling alley. The alcoholic beverages shall be sold for consumption only on the premises by patrons of the facility and their guests -- Annual Fee \$800.00
- Class G: Retail sale of alcoholic beverages by the drink or pitcher only, for consumption on the premises only, in the course of a rental hall business. Patrons cannot act as bartenders or otherwise dispense alcoholic liquor. When the premises are used for the sale of alcoholic liquor, the licensee or a manager acting on behalf of the licensee must be on the premises -- Annual Fee \$250.00
- Class H: Retail sale of alcoholic beverages by a caterer or current holder of another class of liquor license in connection with the sale of prepared food, for service at private parties, weddings or other similar events which are not open to the general public, at a location other than the premises leased, owned, or otherwise operated by the licensee. The location of the catered event shall be deemed the licensed premise. Gross revenue from the sale of alcoholic liquor at any event catered by the holder of a Class H license shall not exceed forty percent (40%) of the total gross revenue generated from the sale of alcohol and food at the event ("the forty percent rule"). An affidavit certifying compliance with the "Forty Percent Rule" shall be submitted on a quarterly basis to the Liquor Commissioner. The holder of a Class H license may enter into a contract with another individual or entity for food service at the catered event, so long as a copy of said contract is available for inspection on the premises of the catered event for the entire length of the event. No catered event by the holder of a Class H license shall exceed three days in length, nor shall alcoholic liquor be served at such event for more than eight (8) consecutive hours -- Annual Fee \$250.00
